

### Plans Submitted

e're delighted to announce that the plans for the second phase of the regeneration of Ebury Bridge have been submitted to Westminster Council's Planning Department. The plans bring to life the detail on the two taller buildings along the railway and the new homes on Ebury Bridge Road. It will set out how the new public squares will be built and the new retail offer along Ebury Bridge Road.

Over the past 21 months we've been consulting with Ebury Bridge residents and neighbours living close to the estate. Their feedback has been used in the final designs that have been submitted to the Local Planning Authority.

Some of the key alterations have included;

- A stronger tree-lined boundary between the Ebury Bridge estate and 1 Ebury Bridge
- A curved pedestrian entrance at the North end of the neighbourhood to prevent bicycles racing down the steps
- Strict management controls on non-residential uses such as community spaces or management hubs.

## Managing the new Ebury

over the past four weeks we asked all Ebury Bridge residents about the future management service at the neighbourhood. We set out proposals that both Westminster Council and a new management provider will deliver the services for returning Ebury residents and new families and individuals moving to Ebury.


Arranging these services are very important with the new homes in Phase 1 due to complete later this year. We want everyone living at Ebury to experience high levels of service and that the buildings and facilities are maintained for generations to come. During the consultation Ebury residents told us how important it would be that any new manager paid close attention to refuse and how people disposed of their rubbish. This will be fed-back


into the specification for the management of the new estate. Some of the key points residents raised were;

- **Refuse Disposal:** Residents want this to be a high priority for any future manager
- Cleanliness Standards: There was an emphasis on maintaining cleanliness in common areas,
- Monitoring Contractor Performance: The importance of residents' involvement in monitoring the performance of services was highlighted.

We'll share a full report into the consultation with all residents in the next few weeks.

# Construction Update

Phase 1 of the redevelopment of the estate is underway.

#### **Present Works**

Work on the Phase 1 buildings is progressing at pace with internal fit-out across the two blocks.

- The 'Benchmark' Social Rent Home is now complete. This home, on the second floor of Mandeville Apartments (Building 8) will set the high standard that all the new homes must meet.
- Temporary landscaping discussions ongoing with hoardings lines to be revised over the coming months
- The lifts on the side of the buildings known as 'hoists' will soon be removed with access to the various floors now undertaken via the internal lifts which are complete

**B**ridge, Westbourne, Rye and Victoria Houses have now been fully demolished as part of Phase 2 works.

JFH will continue to clear obstructions within the site to pave the way for the next on-site works.
